This is a complete violation of Section 19 (6) of the RTI Act, which is produced below: "19 (6) An appeal under sub-section (1) or sub-section (2) shall be disposed of within thirty days of the receipt of the appeal or within such extended period not exceeding a total of forty-five days from the date of filing thereof, as the case may be, for reasons to be recorded in writing."

The Appellant believes that Section (19) of the RTI Act permits any person to appeal before the Honorable Commission if he has been refused access to any information requested under this act or he believes that he has been given incomplete, misleading, or false information under this Act or PIO has obstructed in any manner in furnishing the information.
